President Amanda Cook called the meeting to order. Also present were Lori Callahan, Timothy Callahan, Christine Henderson, Heidi Kaatz, Susie Nitschke, Jim Stiles, and Pastor Jordan Gackle. Tim opened the meeting with prayer. The minutes from the December 2nd meeting were presented. A motion to accept the minutes was made by Susie and seconded by Christine. Motion passed. There is \$12,870.82 in the checking account. Tim made a motion to accept the report, seconded by Susie. Motion carried. Worship: There was no church on December 29th due to weather. Jim has updated the church web-site with a picture of Charles Gray and a short biography.

Property: Christine reported that she received a bill for the paint for the basement from the Kulm Hardware store. She has paid the bill so that amount will be included in last year's budget. Now all that is needed is to set a date and time to do the pre-cleaning and painting.
