Gary will order two air filters for the furnace New Business: During the annual meeting it was proposed that we install a railing for the ramp. Jeremy will check with Jim Steele to ask if he can make one with removable posts. Besides the railing, improvement goals include basement paint & flooring, new window inserts & lighting for sanctuary, bathroom update (handicapped accessible). Susie stressed the importance of finishing one project before moving on to the next. Youth leaders plan to take kids to Thrill Hill to tube in Fort Ransom once they open. Watch for LL DC mission trip fundraising plans. Communion wafers: Susie suggested switching to all gluten free to prevent cross-contamination. Beth will research & order. Ash Wednesday service is on 2/26/20 at 7 pm. Christine will check last year's palm receipt for the number ordered & Amanda will place order. Pastor Jordan is still deciding upon Lenten service plans. Maundy Thursday service 4/9/20 at 7 pm. Easter is 4/12/20. 2020 graduates: Ethan Ellingson. Susie & Beth will plan the celebration; Beth will talk to Ellingsons about a date & ask Kathy to decorate. Jim suggested telling kids to hold microphone close to their lips.
