**New Business:** Half the council members in favor of reopening & half opposed. Christine stated she would not bring forth a motion but would go along with reopening provided strict safety protocols were in place (mandatory masks, social distancing, taping off pews, limited admittance, hand sanitizer). Christine suggested taking reservations each week to regulate attendance. Susie suggested a guest registry we could look back upon in the event someone tests positive. Jeremey suggested pre-packaged individual communion cups & wafers available upon entry with communion taking place in the pews. Susie proposed Nov. 1st for a target reopening date. Christine suggested discussing a capacity limit. Pastor Jordan said he would make an announcement in church on Sun. (He later texted & said he will call members of the congregation individually to get input about re-opening & suggested holding off on a decision until the governor speaks at the end of the week.)

Next meeting is scheduled for 11/17/20 at 7 pm. Jeremy made a motion to adjourn the meeting, Susie seconded, all approved. Meeting adjourned & closed with the Lord's Prayer.
